Act of the State of New Mexico, does hereby certify as follows: 2242908

- 1. The name of the corporation is Estancias Delphine Baca Homeowners
 Association.
 - The period of duration of the Corporation shall be perpetual.
 - The purposes for which the corporation is organized are the following:
 - a. to exist as an association of home owners for the Estancias Delphine
 Baca Subdivision ("Subdivision");
 - b. to hold title to real estate and any and all interests in real estate, to purchase, acquire, sell, convey, mortgage, encumber, lease, grant or receive licenses to, and otherwise deal with property of every kind and description, both real and personal;

The corporation is organized to engage exclusively in such activities as may qualify it for exemption from United States income tax under applicable sections of the Internal Revenue

Code of 1954 as amended (hereinafter referred to as the "Code"). 2242909
